We invite you to join us for facility tours of Avon Lake Regional Water, annual business meeting and awards, and technical sessions at the City of Avon Lake! The Water Filtration Plant provides quality water to over 200,000 people living in a 680-square mile, seven-county area with a maximum capacity of 50 MGD. The Water Reclamation Facility provides the community's need for safe wastewater treatment with a capacity of 6.5 MGD and can accept flows as high as 12.5 MGD during wet weather.
