From South of Dayton – From I -75 North take I-675 North (Exit 43). After 10.4 miles, take the Indian Ripple Rd Exit (Exit 10). Turn Left on to Indian Ripple Road. After traveling 0.6 miles, turn right on County Line Road. Travel 1.6 miles on County Line Rd to Spaulding Rd. Turn Left on Spaulding Rd. The Admin Bldg will be on the right after about 0.3 miles.

From North of Dayton – From I-75 South take Exit 52B. Keep left at the fork and merge onto US 35 East toward Xenia. After 5.7 miles, take the Linden Ave. Exit. Turn right on Linden. After 0.2 miles turn Left on Spaulding Road. The Admin Bldg will be on the left after about 1.3 miles.

From East of Dayton – From I -70 West take I-675 South (Exit 43). After 16.5 miles, take the Indian Ripple Rd Exit (Exit 10). Turn Right on to Indian Ripple Road. After traveling 0.4 miles, turn right on County Line Road. Travel 1.6 miles on County Line Rd to Spaulding Rd. Turn Left on Spaulding Rd. The Admin Bldg will be on the right after about 0.3 miles.
