

## Public Hearing on Objection to Reissuance of the City of Euclid, Ohio NPDES Permit

The U.S. Environmental Protection Agency provides notice that it has scheduled a public hearing in accordance with Title 40 of the Code of Federal Regulations section 123.44(e) upon receiving requests for a public hearing regarding U.S. EPA's November 2, 2021, objection to the Ohio Environmental Protection Agency's reissuance of the City of Euclid's National Pollutant Discharge Elimination System permit (OH0031062). The specific ground for objection is that the proposed permit fails to include effluent limitations for phosphorus necessary to achieve water quality standards for Lake Erie central basin open water, which is designated for public water supply use, as required by Section 301(b)(1)(C) of the Clean Water Act, 33 U.S.C. § 1311(b)(1)(C), and 40 C.F.R. § 122.44(d)(1).
